SYNOPSIS:	The City could not identify LPG vehicles in its fleet which would meet the operational requirements. Project Title:	Procure Seven Heavy-Duty LPG Vehicles and Install EV Charging
MSRC Funding:	\$244,000
Contract Term:	February 13, 2015 to April 12, 2022
Current Request:	Reduced scope and value, substitute CNG for LPG, and six-month term extension
Previous Requests:	Six-month term extension

<u>Project Description:</u> The MSRC awarded the City \$244,000: \$210,000 to procure seven heavyduty LPG vehicles equipped with engines meeting the 0.2 g/bhp-hr NOx standard, or better; and \$34,000 towards the installation of six Level II EV charging stations, at least five of which must be publicly accessible. The City has placed one heavy-duty CNG vehicle into service and completed installation of the charging stations; nothing has been paid to date on this contract. <u>Previous Requests:</u> In July 2021, the City indicated that the COVID-19 pandemic and understaffing had delayed the preparation of their final report and invoicing. They requested a six-month term extension. This request was process administratively.

<u>Contract Request:</u> The City could not identify LPG vehicles in its fleet which would meet the five-year operational requirements of Contract #ML14012, or even be very close to doing so. Therefore, the City is requesting to reduce the number of vehicles from seven to one. The City understands that this would involve \$180,000 a contract value reduction.

The one vehicle identified is CNG rather than LPG. Both fuel types were equally eligible under the MSRC's FYs 12-14 Local Government Match Program. The CNG vehicle would have been approved if originally proposed.

Lastly, the City indicates that impacts of the COVID-19 pandemic and understaffing have continued to impede their report preparation and invoicing efforts. They request a six-month contract term extension.

Project Title:	Future Communities Partnership Program
MSRC Funding:	\$2,000,000
Project Term:	July 13, 2018 to August 31, 2022
Current Request:	
Previous Requests:	Modify one project, modify payment schedule, and one-year term extension; six-month term extension; reallocation of costs between tasks

<u>Project Description</u>: The MSRC awarded SCAG \$2,000,000 to partner on their broad-based regional program to support city and county agencies in implementing pilot projects that reduce vehicle miles traveled (VMT) from local travel and municipal operations through the use of new technologies and enhanced data analytics. Contract #MS18015 was executed to effectuate the award, and the MSRC approved the specific list of projects in April 2019. Nothing has been paid to date on this contract.

<u>Previous Requests:</u> SCAG was able to accomplish Task I (Research Promising Practices) and Task II (Selection of Specific Project Elements) at lower costs than anticipated. SCAG requested to reallocate \$50,000 from Task I, \$40,000 from Task II, and \$10,000 from Task IV (Reporting) to Task III (Implementation). At their April 2019 meeting, the MSRC considered and approved these reallocations. Subsequently, in September 2019 SCAG indicated that the initial administrative processes for some communities had taken longer than anticipated. SCAG requested a contract term extension to August 31, 2021 to allow time for appropriate data collection and to align deadlines with their other funding source. This modification was processed administratively. Then in the Fall of 2020, SCAG indicated that the COVID-19 pandemic had significantly delayed implementation of most projects in the program. SCAG requested a one-year term extension to allow partnering agencies the flexibility to compensate for lost time and determine if additional modifications may be necessary to complete project work. In particular, the City of Monrovia had been compelled to develop a new scope of work for their project. SCAG requested approval of the revised project list, substituting the proposed bike share and bike delivery incentive program for the shared ride program in Monrovia. Lastly, due to the expiration of certain co-funding sources, SCAG requested modifications to the payment schedule, which would result in a net increase in total co-funding. At their December 2020 meeting, the MSRC considered and approved these modifications.

<u>Contract Request:</u> SCAG indicates that four pilots are expected to be complete by the current deadline of June 30, 2022: Glendale, Monrovia, San Bernardino County, and Riverside. Meanwhile, supply chain pressures and staffing capacity challenges associated with the COVID-19 pandemic have continued to delay the Anaheim, Cerritos, Los Angeles, and Ontario project elements. Allowing an adequate window for meaningful data collection is viewed as critical to the success of each pilot project. Therefore, SCAG requests a nine-month term extension to allow them to complete the work.

## Subject: Contract Timeline Extension for No. MS18015C

Dear Ms. Ravenstein:

The Southern California Association of Governments (SCAG) and the Future Communities Partnership Program (FCPP) would like to officially request a contract extension for Contract No. MS18015C. We are requesting a ninemonth extension to amend the contract timeline, which is currently planned for termination effective August 31, 2022. The FCPP project team is proposing a new termination date effective May 31, 2023, with the Final Report completed no later than March 31, 2023.

The ongoing COVID-19 pandemic has continued to disrupt FCPP implementation efforts, and while some pilots remain on-track, others continue to experience delays. The FCPP project team expects four pilots to be completed this summer, including Glendale, Monrovia, San Bernardino County, and Riverside, with the Riverside team currently coordinating to finalize the pilot deliverables and champion the program's first successful pilot conclusion. Altogether the four are anticipated to be completed by original program deadline of June 30, 2022.

Supply chain pressures coupled with staffing capacity and labor and material shortages have impacted the other pilots however, particularly for Anaheim and Ontario. In the case of Anaheim, it has halted implementation and data collection until resolved. Staffing and capacity issues have been consistent throughout the pandemic, but they are especially felt when working with external project partners or supporting vendors. The Cerritos and Los Angeles pilots have felt this impact. As a result, some critical milestones are taking longer to reach.

Additionally, as the current termination date continues to approach, the window for meaningful data collection grows smaller, which is critical to the success of each pilot project. The Anaheim, Cerritos, Los Angeles, and Ontario pilots will benefit from an extended timeline to allow the consultants, researchers, and FCPP project team members to continue data collection and analysis beyond the current project deadline. This will strengthen the findings, final report, and deliverables.
