4.	Consider Modified Lighting and One-Year Term Extension by City of Fontana, Contract #ML16047 (\$500,000 – Enhance Existing Class I Bikeway)	Ravenstein
	This project would enhance the existing San Sevaine Class I Bikeway through the installation of lighting and chain link fencing and paving an access segment. The City indicates that with final design approval for the project, the estimated cost had increased dramatically, requiring the City to secure additional funding to meet the shortfall. They have done so, but the project has in consequence been further delayed. The City requests a one-year term extension. Additionally, a change in the lighting type is proposed to reduce the risk of vandalism. This contract was	

previously extended a total of five years. The MSRC Contracts Administrator recommends approval with the condition that this be the final extension.

#### 5. Consider Authorizing Issuance of New Contract to Complete Work Initiated by City of Yucaipa under Contract #ML16057 (\$380,000 – Implement a "Complete Streets" Pedestrian Access Project)

After previously having been granted extensions totaling 5 years, Contract #ML16057 lapsed, with the City having completed the sidewalk element and a portion of the work on the bicycle lane element. Completion of the bicycle lane is delayed due to drainage and waterline improvement projects under the jurisdiction of other agencies with uncertain timelines. The City of Yucaipa requests MSRC consideration of two alternatives. The first alternative is issuance of a new 21-month contract in the amount of \$380,000 for the entire original scope of work. The second alternative is issuance of a new six-month contract, in an amount not to exceed \$174,420, for the sidewalk element only. The MSRC Contracts Administrator recommends approval of a six-month, \$174,420 contract to allow the City to submit a final report and be reimbursed for the completed element.

## FYs 2016-18 WORK PROGRAM

#### Consider Nine-Month Term Extension by City of Carson, Contract #ML18057 (\$106,250 – Purchase 5 Light-Duty ZEVs and Install Charging Infrastructure)

The City requests an extension to August 31, 2027, approximately a nine-month term extension, due to longer than expected time for design and for selection of a construction contractor for the stations. This contract was previously extended a total of 41 months. The MSRC Contracts Administrator recommends approval with the condition that this be the final extension.

## FYs 2018-21 WORK PROGRAM

#### Consider 18-Month Term Extension by Southern California Association of Governments (SCAG), Contract #MS21005 (\$16,751,000 – Last Mile Freight Program)

SCAG requests an 18-month term extension due to various issues encountered by project participants including delay in delivery of vehicles from the manufacturers, longer than anticipated memorandum of understanding negotiation processes, and issues with product safety. This contract was previously extended a total of 18 months. The MSRC Contracts Administrator recommends approval.

8. Consider Reduced Scope and Value by City of Gardena (GTrans), Proposed Agreement #MS24007 (Awarded \$475,312 – Implement GTrans Microtransit Service)

The proposed agreement to effectuate the MSRC's award for Gtrans' microtransit service in the City of Gardena was under development, but not yet executed, when Gtrans notified MSRC staff of changes in the anticipated project scope. Customer feedback resulted in the paratransit fare being held consistent with their on-demand fare at \$0.75. Gtrans also encountered some difficulties in hiring drivers for the project. Therefore, Gtrans requests to reduce the proposed hours of operation on the weekends, eliminating Sunday service and moving back the Saturday start time from 8:00 a.m. to 10:00 a.m. Weekday hours would not change. In consideration of the reduced service hours, Gtrans proposes that the award amount for the operational costs be reduced proportionally, for a total reduction of \$51,178 and proposed agreement value of \$424,134. The MSRC Contracts Administrator recommends approval.

#### 9. Consider Proposed Amendments to MSRC "Operational Policies and **Ravenstein** Procedures" (Ravenstein)

The MSRC's "Operational Policies and Procedures" were originally adopted in 1993, and amended with respect to the Regional Rideshare Agency in 2020. This item provides a more comprehensive set of recommended updates for consideration.

## FYs 2016-18 WORK PROGRAM

## Agenda Item #7 – Consider Nine-Month Term Extension by City of Gardena, Contract #MS18027 (\$365,000 – Install New Limited Access CNG Station, Modify Maintenance Facility & Train Mechanics)

Cynthia Ravenstein, MSRC Contracts Administrator, explained that the City of Gardena was awarded \$365,000, not \$80,000 as stated by error in the staff report. The City was awarded funds under the Natural Gas Infrastructure Program to install a new limited access, natural gas fueling station, to make modifications to their maintenance facility, and to obtain technician training. The City has previously received extensions totaling 28 months, but they are now in the final stages of construction and are hopeful that they will complete construction by the end of December. Beyond completing construction, the City also needs to pass inspections, receive approval for pending permits and complete electrical connections. The Contracts Administrator recommends approval based on the City only requesting nine months and being very close to completing their project.

MSRC-TAC Member Jason Farin stated that many times a project may think they are on a good schedule until something happens and it gets put back even further. Mr. Farin asked whether the City of Gardena has expressed that there is a possibility that this project could go beyond the nine-months extension.

Ms. Ravenstein answered stating that the City had initially requested a six-month term extension, but she asked them to reevaluate and they came back with a nine-month term extension request to be safe.

ON MOTION BY MSRC-TAC MEMBER JACK GARATE AND SECONDED BY MSRC-TAC MEMBER JASON FARIN, THE MSRC-TAC UNANIMOUSLY VOTED TO RECOMMEND TO APPROVE FOR THE CITY OF GARDENA, CONTRACT #MS18027, A NINE-MONTH TERM EXTENSION.

ACTION: MSRC staff will include this contract modification on the next MSRC agenda for approval.

## FYs 2021-24 WORK PROGRAM

#### Agenda Item #8- Receive Update on FY 2021-'24 Work Program – Goods Movement

Ray Gorski, MSRC Technical Advisor, gave a presentation updating the MSRC-TAC on the goods movement aspects of the FY 2021-24 Work Program. The Ports of Los Angeles and Long Beach have offered to invest in projects which responded to the MSRC's zero emission infrastructure Request for Information (RFI). This would involve five RFI responses, with a total of nine sites, and the total cost of these projects at the time of submission was a little over \$140 million. The Ports would like to partner and fund up to \$28.5 million. This would fund 100% of the amount requested from MSRC, and it would allow the MSRC to expand the number of projects that could have been funded under this RFI. The MSRC will take responsibility for administering these projects, but they will be one hundred percent funded equally by the Ports of Los Angeles and Long Beach. The MSRC and South Coast AQMD will execute MOUs to enable the transfer of funds from the Ports to the MSRC.

Mr. Gorski notified the MSRC-TAC about the South Coast AQMD Zero Emission Infrastructure Program. The program is for up to \$200 million under the Carl Moyer Program and other funding to implement zero emission infrastructure for both medium and heavy-duty vehicles and will support both electric vehicles charging as well as hydrogen refueling. This program will close on February 6th, which is a short timeline. However, it is a great opportunity for the MSRC to fund some of the remaining RFI shovel-ready projects. There are six projects left under the MSRC Infrastructure RFI that would potentially be a good fit with the South Coast AQMD program. The MSRC could offer cash co-funding for select projects, however the respondent would be responsible for submitting the application to the South Coast AQMD. Some respondents have already reached out to MSRC staff and expressed an interest in this sort of arrangement. The next steps would be for staff to reach out to the remaining RFI respondents and gauge their interest in a potential partnership. We would work with them to develop a split between their ask under the Carl Moyer Program and what the MSRC could be co-funding. This would then be brought back to the MSRC-TAC and MSRC for review and approval.

Mr. Gorski updated the MSRC-TAC on a potential partnership between the MSRC and LA Metro. Metro has funding available to support clean goods movement trucks along the Interstate 710 (I-710) corridor. There is an opportunity for the MSRC to work with LA Metro on projects of mutual interest. The MSRC staff, Metro staff and as well as legal counsel from South Coast AQMD and LA County have been reviewing a draft Memorandum of Understanding that would allow funding to flow between Metro and the MSRC. This could be used to fund joint projects of mutual benefit along the I-710 corridor. We are also exploring the potential to release a joint RFP for zero-emission infrastructure projects. This would leverage the Metro clean trucks money as well as the MSRC Discretionary Fund. It could be funded under the current Work program or the MSRC could entertain having it as an element of their 2025 Work Program.

MSRC-TAC Vice-Chair Minh Le asked how the MSRC and agency collaborations can leverage the millions of dollars currently and potentially available to attract the hundreds of millions in Federal dollars into our region to address climate pollution reduction.

Mr. Gorski stated that the MSRC would need a public agency to take a leadership position for the MSRC to coordinate with. The South Coast AQMD as the lead agency of the region would

have a direct mechanism to work with the MSRC. If another agency is going to take the lead on behalf of the region, then we'd need to understand who that entity is and what the potential role of the MSRC could be.

Mr. Le stated that the submission from our region would need to be submitted in March or April. The State will be submitting their application for the full \$500 million in programs, but it is possible that some secondary organization in California could potentially get a large award up to \$500 million. Pulling our organizations together across multiple regions would be beneficial.

Mr. Gorski stated that the MSRC would have a discussion with the South Coast AQMD internally to understand their position and intentions and then update the TAC in January as to what the MSRC's potential role could be.

#### **Contract Execution Status**

#### 2021-24 Work Program

On September 2, 2022, the SCAQMD Governing Board approved an award under the Major Event Center Transportation Program. This contract is executed.

On February 3, 2023, the SCAQMD Governing Board approved an award under the Transformative Transportation Strategies & Mobility Solutions Program. This contract is executed.

On June 2, 2023, the SCAQMD Governing Board approved six awards under the Microtransit Service RFP, for zero-emission shared mobility service. These contracts are under development, under internal review, with the prospective contractor for signature, or executed.

On September 1, 2023, the SCAQMD Governing Board approved two awards under the Publicly Accessible Goods Movement Zero Emission Infrastructure Request for Information. One of these contracts will be administered by SCAQMD on behalf of the MSRC, and the other award is conditional upon successful selection of a site developer and operator and securing co-funding commitments.

On November 3, 2023, the SCAQMD Governing Board approved an allocation for partnership with SCAQMD and other partners in proposals seeking funding under the CARB "Advanced Technology Demonstration and Pilot Projects" solicitation. If proposal(s) are awarded funding, contract(s) will be administered by SCAQMD on behalf of the MSRC.

Previous Requests:	Two-year term extension; two-year term extension; one-year term extension

<u>Project Description</u>: The City was awarded \$500,000 under the MSRC's FYs 2014-16 Local Government Match Program to help enhance the existing San Sevaine Class I Bikeway by paving an access segment, installing lights and installing fencing. A construction contract has been executed; nothing has been paid to date on this contract. <u>Previous Requests</u>: The project was originally expected to proceed through Caltrans' conventional encroachment permit process. It transpired that the project cost within the Caltrans right of way exceeded the encroachment permit threshold and the project needed to go through a Caltrans oversight process, adding at least one year to the project schedule. Additionally, two of the primary staff for the project left City employ, requiring new staff to be assigned and come up to speed. Finally, during the geotechnical boring work, the crew accidently hit a private water line. This had to be repaired, and the liability resolved, resulting in additional months of delay. The City requested, and the MSRC approved, a two-year contract term extension.

Later, the City reported that they were able to reach a critical milestone with a conditional approval of the Wall Type Selection Report with Caltrans. However, the City also was informed of the need to perform additional borings along Interstate 15. They needed to establish acceptable locations to perform the borings and an encroachment permit from Caltrans. Given this additional work and delay, the City requested, and the MSRC approved, a one-year term extension.

Subsequently, the City indicated that the project has been further delayed due to the need for extensive coordination with other agencies having jurisdiction, including Caltrans, San Bernardino County Flood Control District, and the City of Rancho Cucamonga. Additionally, the City had needed to go through the courts to acquire the necessary right of way from a property owner. In order to allow sufficient time for completion of construction, they requested a two-year term extension. The MSRC Contracts Administrator denied the City's request. The City requested MSRC review of this denial, and the MSRC granted the City's request.

<u>Contract Request</u>: The City indicates that with final design approval for the project, the estimated cost had increased dramatically. Since the application for the MSRC's Local Government Match Program was submitted in 2015, the total project cost has increased from \$1,000,000 to over \$13,000,000, requiring the City to secure additional funding to meet the shortfall. They have done so, but the project has in consequence been further delayed. The City requests a one-year term extension. Since construction is expected to complete in December 2024, this schedule has some flex for unforeseen delays.

Additionally, a change in the lighting type is proposed to reduce the risk of vandalism. Contract #ML16047 specifies the installation of at least 330 solar-powered bollard-style lights along the trail. The City instead proposes to install 78 solar-powered lights mounted on 16-foot poles. Since these lights would be installed higher up, a smaller number would suffice to illuminate the trail, and they are less prone to vandalism.

<u>Recommendations</u>: The MSRC-TAC Scope Changes Subcommittee will review the request and their recommendations will be brought forward at the MSRC-TAC meeting. The MSRC Contracts Administrator recommends approval, contingent on this being the final extension.

Dear Mr. Mackenzie,

The City of Fontana is requesting an 12-month time extension for the San Sevaine Trail, Segment 2 Project (Contract Number ML16047). The term date for the contract is August 5, 2024. In order to meet this deadline, construction will need to be completed by June 30, 2024 to file all required closure paperwork.

After extensive design coordination with Caltrans, San Bernardino County Flood Control District (SBCFCD) and the City of Rancho Cucamonga and with additional grant funding secured from the Department of Parks and Recreation and San Bernardino County Transportation Authority, the project was advertised for bids in October 2023, awarded in December 2023 and will be ready to begin construction in April or May of this Year.

With the final design approval of the project from all stakeholder agencies this past summer, the engineer's estimate increased significantly necessitating additional funding for the project. Additional funds from the Carbon Reduction Program (CRP) were secured in Fall prior to going out to Bid. Unfortunately, even with the additional funds, the lowest bid received was nearly \$ 4 Million over the engineer's estimate. Additional Recreational Trails Program (RTP) Grant funds and CRP Funds have been secured to close the funding shortfall. Since the application for the MSRC Grant was submitted in 2015, the total project cost has increased from \$1,000,000 to over \$13,000,000.

Now that full project funding has been secured and a construction contract has been executed, we are optimistic that our efforts over the last several years will deliver the project to the community by the end of calendar year 2024 barring any unforeseen circumstances during construction. An 12-month extension is being requested to account for any unforeseen delays that may occur during construction

given the complexity of the project and the various agencies that must sign off on the final construction acceptance.

The following schedule is the latest with the recent delay factored in:

- Bid Opening October 2023
- Agency Award of Construction Contract December 2023
- Contract Execution January 2024
- Begin Construction Phase March/April 2024
- Complete Construction December 2024 (Barring unforeseen delays)
- Construction Acceptance by all agencies March 2025

With construction acceptance projected for early 2025, this will allow for the necessary time to file all required completion forms by August 5, 2025.

While the complexities of the project have resulted in a longer delivery time, it is an important project that will greatly enhance non-motorized access to the regional trail network, schools, and other points of interest. Many within the community are anxiously awaiting the delivery of the project. After considerable effort, and an investment to date over \$1,307,000, the project finish line is in view. Denial of this request will create a funding shortfall, jeopardizing project delivery at this critical phase of the project.

Lastly, in addition to the request for a time extension, a change in scope is included in this request with respect to the type of lighting that will be used in the project. The original application submitted proposed solar bollard type lighting not more than 36" tall. This lighting was not endorsed by maintenance staff that would be responsible for the ongoing maintenance of the trail as the lighting would be subject to vandalism. As a result, the lighting was changed to a pole mounted light more than 10' tall to reduce the risk of vandalism. The lights remain solar powered. Your consideration and approval of this change in lighting type is requested along with the time extension request.

The City appreciates your consideration and partnership on this regionally significant project.

SUBJECT:	Authorize Issuance of New Contract to Complete Work Initiated by City of Yucaipa under Contract #ML16057
SYNOPSIS:	After previously having been granted extensions totaling 5 years, Contract #ML16057 lapsed, with the City having completed the sidewalk element and a portion of the work on the bicycle lane element. Completion of the bicycle lane is delayed due to drainage and waterline improvement projects under the jurisdiction of other agencies with uncertain timelines. The City requests MSRC consideration of two alternatives. The first alternative is issuance of a new 21-month contract in the amount of \$380,000 for the complete scope of work. The second alternative is issuance of a new six-month contract, in an amount not to exceed \$174,420, for the sidewalk element only. This project is part of the FYs 2016-18 Local Government Partnership Program.
FINANCIAL IMPACT:	Nothing has been paid to date under #ML16057. \$380,000 remains committed towards the "Complete Streets" improvements, and will become available to fund a replacement contract if so authorized by the MSRC.
RECOMMENDATIONS:	The MSRC Contracts Administrator recommends approval of a six- month contract in a value not to exceed \$174,420 to allow the City to submit a final report and be reimbursed for the completed element.
ATTACHMENTS:	Contractor's letter requesting replacement contract and outlining two options

**DISCUSSION:** The City had submitted two applications for "Complete Streets" category projects under the MSRC's FYs 2016-18 Local Government Partnership Program. Because the total award to any single entity under this category was limited to \$500,000, the City agreed to adjust their funding request for improvements on County Line Road to \$380,000 (the other project, for improvements on Yucaipa Boulevard, received an award of \$120,000 and was effectuated under a separate contract). The MSRC approved this request and Contract

#ML16057, with \$205,580 for bike lanes and \$174,420 for pedestrian enhancements, was executed to effectuate the award. To date the pedestrian enhancements, as well as a portion of the preliminary work for the bike lanes, have been completed. Nothing has been paid to date on this contract.

# Previous Requests:

- In October 2018, the City indicated that the specified work was part of a larger project in partnership with the City of Calimesa, and execution of an agreement with Calimesa had taken longer than expected. The City requested a one-year contract term extension. This modification was processed administratively.
- In November 2019, the City indicated that the coordination of environmental clearance requirements and right-of-way acquisition with their partner agencies was taking even longer than previously anticipated. The City requested, and the MSRC approved, a one-year term extension.
- In November 2020, the City indicated that the need for coordination of review with a larger multi-agency project further delayed progress on project design and engineering. The City now expected to advertise for construction bids in June 2021. They requested, and the MSRC approved, a one-year contract term extension.
- In October 2021, the City indicated that the same factors were continuing to contribute to delays. They said that the plans for the sidewalk additions were fully approved in July 2021, and they were now in the final stages of acquiring the necessary right-of-way to construct the proposed improvements. The City forecasted that the project would be complete by July 2022. The City requested, and the MSRC approved, a one-year term extension.
- In December 2022, the City indicated that delays due to staffing and COVID restrictions greatly increased the time necessary for review and processing of the environmental documents. The City requested a one-year term extension to allow time to complete construction. The MSRC approved the request, contingent upon award of a construction contract by January 31, 2023.

<u>Contract Request</u>: MSRC staff confirmed that the City met the contingency of awarding a construction contract in a timely manner, and were under the impression that construction had been completed. However, it transpired that this completed construction was only for the pedestrian elements of the contract. The City has also completed portions of the bike lane preparatory work: street widening, curb and gutter, and driveway approaches. Bike lane elements which remain to be completed include installation of the asphalt pavement overlap, thermoplastic bike lane striping and bike lane signage. Until these elements are completed, however, this does not constitute an eligible project under the FYs 2014-16 Local Government Match Program. This misunderstanding regarding the degree of completion was only discovered when contract expiration was imminent, and the contract has now lapsed.

The City indicates that the remaining bike lane improvements cannot be completed until after drainage and waterline improvements have been completed, both of which are managed by other agencies. If the City were to proceed with the bike lane improvements at this time, they would be removed and/or damaged by this work. The City has requested a new contract for one of two options:

- 1. (The City's preferred option) A contract for the full scope of ML16057, valued at \$380,000, with an end date of January 2026; or
- 2. A contract for the pedestrian elements of ML16057, valued at \$174,420.

<u>Recommendations</u>: The MSRC Contracts Administrator recommends approval of a contract in a value not to exceed \$174,420 to allow the City to submit a final report and be reimbursed for the completed element. While the City did not specify an end date under Option 2, a six-month term ought to be sufficient.

Regarding Contract #AB2766/ML16057, the City of Yucaipa would like to formally request a new contract with a contract term that extends to January, 2026. The current contract has a contract term that ends January, 2024.

The City of Yucaipa has completed the construction of a majority of the MSRC grant funded components for our County Line Road Improvement Project. The scope of completed work includes construction of street widening, curb & gutter, driveway approaches and sidewalk along County Line Road from Calimesa Blvd to 450' west of 4<sup>th</sup> Street, excluding the intersection at 5<sup>th</sup> Street and County Line Road. The grant funded items that remain to be completed include installation of the asphalt pavement cap, thermoplastic bike lane striping and bike lane signage (bike lane improvements).

The MSRC grant funded project (MSRC Project) is part of a larger County Line Road Corridor Project from Calimesa Boulevard to Bryant Street (Corridor Project). The Corridor Project includes multiple phases of work, including storm drain improvements and waterline improvements. Both of these projects are managed by other agencies, the City of Calimesa and South Mesa Water Company. These drainage and waterline improvements are located within the limits of the MSRC Project. (Please see attached exhibit showing limits of work for the storm drain and water main in reference to the MSRC project.)

The bike lane improvements cannot be completed until after the drainage and waterline improvements have been completed, as they required significant trench construction within the bike lane improvement areas which would remove and/or damage the new bike lane improvements and prevent the City from collecting bicycle and pedestrian counts in accordance with the MSRC grant. The City of Yucaipa plans to complete the bike lane improvements once the drainage and waterline improvements

are completed, at which time the City can ensure the bike lane improvements are not removed and the City can successfully collect bicycle and pedestrian counts. The City of Yucaipa has requested schedules for the drainage and waterline improvement projects. Schedules have not been provided, although these improvements are anticipated to be completed by the end of 2025.

The City is committed to completing the bike improvements as soon as possible, and in order to accomplish this the City would like to request a new contract with a term that extends until January, 2026. Option 1, the City's preference for a new contract, is to utilize all grant funds allocated to the MSRC project and to complete all improvements identified in the MSRC Project with a new contract end date of January, 2026 (Option 1).

Should Option 1 not be feasible, a second option (Option 2) could be to replace the existing contract with a new contract which encompasses only the pedestrian improvements that have been completed and the elimination of the bike lane improvements from the scope of work. The City has spent \$137,256 for design costs, \$460,284 for construction costs and \$38,078 for administrative costs to complete MSRC Project pedestrian improvements, resulting in a total of \$635,618 in expenditures to date for the pedestrian components of the MSRC project. The original estimated MSRC project total is in the amount of \$880,016, with an estimated total cost of \$403,927 for the pedestrian improvements. Under Option 2, the new contract would be reduced to match the original pedestrian improvement estimate. The new contract would be reduced to a total project cost in the amount of \$403,927 with a grant participating cost in the amount of \$174,420. Compared to the original grant contract, the City's Additional Project Co-funding (not matched) under Option 2 would increase from \$55,087 to \$286,778. See table below for cost comparison of the original to the proposed Option 2 contract.

<u>Project Description</u>: The MSRC awarded the City \$106,250 to procure five light-duty zero emission vehicles and to install EV charging stations. All vehicles have been placed into service and \$50,000 has been paid to date on this contract.

<u>Previous Request</u>: The City indicated that the work associated with the EV charging stations was delayed due to issues arising from the COVID-19 pandemic, staffing turnover, and changes in management and priorities. The City requested a 38-month term extension to allow time to complete the installations and fulfill the three-year operational requirement. <u>The request was reviewed by the MSRC's Contracts Administrator</u>, and the Contracts Administrator denied the City's request because it fell into the following category: the request is for three years or more. The City requested MSRC review of this denial. When the MSRC considered the City's request, the MSRC noted that the City's letter included conflicting information as to when the stations'

installation would be complete. In an effort to accommodate the lengthier scenario, but not to make the contract term longer than necessary, the MSRC approved a modification in which the contract will terminate three years from the commencement of operation of the charging stations, but in no event later than December 15, 2026.

<u>Contract Request</u>: The City now indicates that the time required to procure a design consultant, the plan check approval process, and the time required to advertise and award a construction contract took longer than anticipated. The City awarded a construction contract in January and estimates that construction will begin in March, completing by August 2024. They request a nine-month term extension.

<u>Recommendations</u>: The MSRC-TAC Scope Changes Subcommittee will review the request and their recommendations will be brought forward at the MSRC-TAC meeting. The MSRC Contracts Administrator recommends approval, contingent on this being the final extension.

The contract had two major components, one was to procure five on-road, light-duty zero emission vehicles and the second was to install three, level II, electric vehicle (EV) charging stations. The city met its obligation for the purchase of five zero-emission vehicles and submitted the reimbursement requests accordingly. The level II charging installation, however, has not been completed and the city is seeking additional time to complete this portion of the work. A contract amendment was executed on April 5,2023 where the term of the contract was extended to December 16,2026.

Contract extensions requests requirements:

- 1. The City is requesting an extension to August 31, 2027. The installation of the three, level II, EV charging stations would be complete by August 2024, however, the three-year operation and reporting requirement would be complete by August 2027.

<u>Project Description</u>: The Last Mile component of the MSRC's Regional Goods Movement Program focuses on reducing emissions from transportation of goods following departure from distribution centers. In August 2020, the MSRC approved a sole-source contract award to SCAG in an amount not to exceed \$10,000,000 to implement the Last Mile Freight Program (LMFP) on behalf of the MSRC. Contract #MS21005 was executed to effectuate the award, and in November 2021, the MSRC approved SCAG's proposed project list awarding the original \$10,000,000 to 26 projects across the region. Subsequently, the MSRC approved the allocation of additional funding and the addition of six projects from SCAG's contingency list (one of which provided additional funding to bring one of the original projects to its full requested amount). Eight projects have now withdrawn, resulting in a total project count of 23. \$62,085.88 has been paid to date on this contract.

<u>Previous Requests</u>: In November 2021, the MSRC provided guidance to SCAG staff to work with MSRC staff and the TAC Last Mile Subcommittee to revisit the contingency list projects. The TAC Last Mile Subcommittee and the TAC reviewed SCAG's proposed funding strategy and recommended approval of a \$6,751,000 contract value increase to Contract #MS21005 to support six additional zero emission LMFP projects which would also meet the Program's geographic and small-sized business guidelines. Additionally, SCAG indicated that supply chain constraints were impacting vehicle and equipment procurement schedules. SCAG requested an 18-month contract term extension to allow Project Participants adequate procurement time. The MSRC approved the additional project funding and extension at their January 2022 meeting.

Contract #MS21005 provides that if a Project Participant withdraws, SCAG may request the MSRC to approve a reallocation of the funds assigned to that project to increase the scope of another project on the approved list or to fund another project on SCAG's contingency list. In September 2022, SCAG indicated that three of the previously approved projects, which had a total incentive funding allocation of \$2,231,952, had withdrawn. SCAG determined that Project Participants Sysco Corporation and Zeem Solutions would be willing to accept additional funds and increase the scope of their projects accordingly. SCAG requested the MSRC to divide the \$2,431,952 equally between Sysco and Zeem. If the reallocation were approved, Sysco would increase the scope of their project from 9 vehicles and 9 chargers to 17 vehicles and 17 chargers. Zeem Solutions would increase their project scope from 42 vehicles and 1 mobile power station through the addition of 66 chargers. These would be deployed at Zeem's Santa Ana depot, increasing the geographic scope of the project into Orange County.

At their October 2022 meeting, the MSRC-TAC considered SCAG's request and recommended approval. A few days prior to the October 2022 MSRC meeting, Zeem Solutions notified SCAG that their Santa Ana infrastructure capacity study revealed the proposed site for domiciling infrastructure did not at that time have the power capacity necessary to house the 66 proposed chargers. In light of this new information, the MSRC approved the reallocation of \$1,115,976 to Sysco as well as reserving \$1,115,976 without immediate assignment to a specific project, contingent upon receipt of an additional reallocation request from SCAG no later than February 17, 2023.

SCAG notified MSRC that around the time of the MSRC's determination in October 2022, they were notified by an additional Project Participant that they were withdrawing from the program. This project, with a small business owner-operator, had been awarded \$70,000 and was expected to deliver one natural gas truck to be domiciled in Los Angeles County. In early December 2022, SCAG formally requested that this \$70,000 be combined with the \$1,115,976 previously reserved by the MSRC, allowing them to bring forward a request for a full reallocation of \$1,185,976. This request was processed administratively.

In January 2023, after thorough review, SCAG proposed that the \$1,185,976 then available be reallocated to Zeem Solutions. As noted at the October 2022 MSRC meeting, Zeem's targeted Santa Ana site was determined not currently to possess sufficient power capacity for 66 chargers. However, Zeem had confirmed that their feasibility assessments showed that this same site location could still be considered through a phased approach. Zeem would initially install 10 Level II chargers and 12 Level III chargers, as well as adding 30 medium-duty zero emission vehicles to be domiciled at this Santa Ana location. The MSRC approved SCAG's request.

In April 2023, SCAG notified MSRC staff that another independent owner-operator, with \$70,000 awarded, had withdrawn. SCAG staff determined that Sysco offered the greatest reallocation benefits. If awarded the additional \$70,000, Sysco would install an additional electric vehicle charger under the program, increasing their total from 17 to 18. SCAG also requested for WattEV to substitute Nikola TRE BEV trucks for some of the Volvo trucks they had originally specified. By so doing, they believe they can meet their existing time commitments under the Last Mile Freight Program. The MSRC approved SCAG's request.

In August 2023, SCAG requested the MSRC to approve modification of the MOU with project participants to allow reimbursement for expenditures made prior to execution of the MOU. The MSRC approved SCAG's request.

<u>Current Request</u>: SCAG indicates that they have experienced delays associated with multiple projects under LMFP. The most pressing issue relates to Project Participant PepsiCo/New Bern Corporation. New Bern has encountered significant delays in the procurement of their Tesla tractors. They now expect these vehicles to be delivered mid-year 2025. Other projects are now technically still able to meet timelines, but any further holdups will cause them to be unable to meet the contract schedule. This includes Quality Custom Distribution, which has a complex arrangement for the ownership of the project's microgrid and chargers which extended their MOU negotiation process, and WattEV, which encountered a manufacturer recall with the first trucks delivered to them.

Additionally, both the Zeem Solutions and Gonzalez Logistics Incorporated (GLI) projects have encountered challenges for which SCAG anticipates bringing forward modification requests in the near future, but which will also be challenged by the current contract schedule. Lastly, three owner-operator projects have withdrawn. It is anticipated that SCAG will soon be submitting a request to reallocate funds from these projects.

At this time, SCAG's request is solely for an 18-month term extension. They have indicated that their rationale for bringing this request forward now, rather than waiting to bring all the anticipated requests at one time, is to be sensitive to the MSRC's preference to receive information regarding contract extensions as soon as possible. Furthermore, if an approval is granted, it will help them to continue managing implementation and working with the Project Participants.

<u>Recommendations</u>: The MSRC-TAC Scope Changes Subcommittee will consider the request, and their recommendations will be brought forward at the MSRC-TAC meeting. The MSRC Contracts Administrator recommends approval.

Dear Ms. Ravenstein:

This letter is being submitted as part of SCAG's request to extend the Last Mile Freight Program contract (MS21005) by an additional 18 months, moving the termination date from July 31, 2025 to January 31, 2027.

This request is being made due to delays experienced by multiple projects within the LMFP. In the most extreme cases, these delays have pushed completion timelines beyond the December 2024 project implementation deadline and July 2025 contract end date. In less extreme cases, projects comply with the current program schedule but are at greater risk of failure should they experience further disruption. The reasons for delay are outside the control of SCAG and even somewhat outside of the control of the project companies. Denial of this extension would negatively impact years of work between SCAG and the MSRC and public-private partnership project relationships. By approving the contract extension request, the MSRC will allow SCAG/awardees to proceed through the implementation and reporting processes for all project component needs while increasing the program's resilience to future disruptions.

Table 1 shows a revised program schedule with updated increments of progress that reflect the requested 18-month extension:

#### Discussion

The program has awarded \$16,751,000 to projects focused on the commercial deployment of zeroemission or near-zero emission (ZE/NZE) heavy and/or medium duty on road trucks (including ZE/NZE equipment and supporting infrastructure). SCAG has completed both Task 1 and Task 2 as outlined in the LMFP contract and is actively engaged in implementation (Task 3) and evaluation/reporting (Task 4). To date, 21 of 23 awardees have entered MOUs with SCAG and are in various stages of implementation. Two (2) of those awardees have completed their full operational and reporting requirements and are in process for reimbursement of their awards, with one already having received partial reimbursement.

SCAG has developed vested relationships through partnering with companies and the agency has spent three years of resources across Planning, Finance, and Legal departments to develop the program and to manage the implementation of these projects. As of February 2024, SCAG has spent over \$200 thousand in salary, fringe, and indirect costs for employees working on the Last Mile Freight Program Overall Work Program (OWP) task number. This figure does not include the additional time and resources spent by supporting departments including Legal and Finance due to separate OWP task numbers. It is estimated that these departments have spent roughly one-quarter of the hours equating to the over \$200 thousand in salary, fringe, and indirect costs for planning staff.

Projects have experienced delays in their project timelines due to a myriad of issues, including interruptions to site acquisition, permitting, and construction, vehicle and infrastructure delivery postponement, and equipment recalls by manufacturers. Extending the contract would allow these projects more time for completion and lower the risk of failure to comply with the existing period of completion. Projects that would benefit from an extended program timeline include:

### PepsiCo/New Bern Corporation | \$1.19M Award / \$2.46M Match | 10 Vehicles

New Bern Corporation has experienced significant delays in the procurement of their Tesla tractors. They have assured SCAG that they are being given priority by Tesla to receive these vehicles before other customers, but even with priority they will not be able to start operating these vehicles in time to meet current program deadlines. SCAG was first notified of Tesla's delivery delays in July 2023 and the New Bern team has been updating SCAG on this issue on a quarterly cycle. Per their latest report, the New Bern team expects these vehicles to be delivered mid-year 2025. An extension of the implementation deadline by 18 months, from December 2025 to June 2026, will provide adequate time to bring all vehicles into service, complete the 6-month operations and data reporting requirement, and complete the Final report before closing out the project. This also provides some additional time should the project timeline be impacted by other disruptions in the future.

#### Quality Custom Distribution | \$4.18M Award / \$16.4M Match | 30 Vehicles, 18 Chargers

QCD's MOU negotiation process took longer than originally anticipated due to discussions related to third-party equipment being acquired for this project. Specifically, the project's microgrid and chargers are owned and operated by vendors, InCharge Solutions and Scale Microgrids. During the MOU negotiation process, construction and commissioning timelines were pushed back to account for complexity in this arrangement, with project implementation now projected to be completed near the deadline of December 2024. While timeline still fits the current contract schedule, an extension would provide the project with flexibility in case of additional delays.

#### WattEV | \$2.96M Award / \$12.61M Match | 20 Vehicles, 18 Chargers

WattEV has experienced delays in the completion of their Gardena and San Bernardino depot sites as well as their vehicle delivery timeline. For their infrastructure locations, complications have come up with the utility being unable to supply the site with power within WattEV's original schedule. For the vehicles, complications are linked to OEM delivery delays and issues with product safety. Specifically, SCAG was notified in October 2023 that WattEV had to send their Nikola trucks back to the manufacturer following a recall by Nikola. While WattEV continues to work with both Nikola and Volvo to ensure their 20 order vehicles is fulfilled in time to comply with LMFP's operational and reporting requirements, there is no denying that these developments put pressure on those timelines.

### Other Projects | \$3.57M Award / \$41.9M Match | 122 Vehicles, 73 Chargers

Both Zeem Solutions and Gonzalez Logistics Incorporated (GLI) have encountered challenges impacting their project completion timelines. In the case of Zeem Solutions, lease negotiations between Zeem Solutions and the landlord at their Santa Ana project halted as the parties couldn't negotiate a financially and operationally viable lease agreement. Unfortunately, this setback was compounded by problems finding a suitable replacement property in Orange County. After months spent searching for a new Orange County location, in December 2024, Zeem indicated they would request an amendment to their project scope by replacing the proposed Orange County depot concept with a project site in Long Beach. SCAG is working with Zeem now to structure a proposal and recommendation for this scope change.

Similarly, GLI was forced by their landlord to find a new location to house their vehicles and chargers shortly after being awarded by the LMFP. After nearly two years of searching for another project site, funds awarded to GLI from CARB and CEC's Zero-Emission Drayage Truck & Infrastructure Pilot Project were canceled by CEC and CARB. SCAG was notified by CARB in October 2023 that they would be canceling this award due to shortfalls with GLI's project. With these withdrawn funds totaling over \$12.5 million, GLI's 50 vehicle and 50 charger procurement has been put on hold until the company can secure replacement funds from other funding sources. SCAG is working with GLI to determine the most optimal accelerated path forward and will develop the appropriate proposal and recommendation.

Based on these issues, each company's ability to finish their projects within the current period of completion is at risk and both have been precluded from completing their MOUs.

#### Recommendation

SCAG recommends extending the contract by 18 months to allow these projects more time for completion and increasing the program's resilience to future disruptions. Should this extension be denied, it may result in projects reaching the end of the eligible window with components of their project still incomplete. In-turn, these projects would be ineligible to receive their full LMFP award, and in most cases no award at all. This may further require delays and the need for projects to seek different funds or in a worst case, be incapable of completing all elements of the project towards commercial deployment.

SYNOPSIS:	The proposed agreement to effectuate the MSRC's award for Gtrans' microtransit service in the City of Gardena was under development when Gtrans notified MSRC staff of changes in the anticipated project scope. Customer feedback regarding their proposed paratransit fare has resulted in the fare being held consistent with their on-demand fare at \$0.75. Gtrans also encountered some difficulties in hiring drivers for the project. Therefore, Gtrans requests to reduce the proposed hours of operation on the weekends, eliminating Sunday service and moving back the Saturday start time from 8:00 a.m. to 10:00 a.m. Weekday hours would not change. In consideration of the reduced service hours, Gtrans proposes that the award amount for the operational costs be reduced proportionally, for a total reduction of \$51,178 and revised proposed agreement value of \$424,134. This project is part of the FYs 2021-24 Microtransit Program.

<u>Project Description</u>: The MSRC awarded GTrans \$475,312 to provide micro-transit services within an approximately 20 square mile area of Gardena, California. A proposed agreement to effectuate the award was under development, but not yet executed. Nothing has been paid to date.

<u>Contract Request</u>: Gtrans notified MSRC staff of changes in the anticipated project scope. Gtrans had originally anticipated setting their fares for the paratransit service at \$1.50, compared to a \$0.75 fare for their on-demand service. Customer feedback resulted in the paratransit fare being held at \$0.75. Gtrans has committed to providing the same level of match funding as proposed in their original application, despite the lower paratransit fare they will recoup.

Gtrans also encountered some difficulties in hiring drivers for the project. Therefore, Gtrans requests to reduce the proposed hours of operation on the weekends, eliminating Sunday service and moving back the Saturday start time from 8:00 a.m. to 10:00 a.m. Weekday hours would not change. In consideration of the reduced service hours, from 88 to 77 per week, Gtrans proposes that the award amount for the <u>operational</u> costs be reduced proportionally, for a total reduction of \$51,178 and proposed agreement value of \$424,134. The \$65,886 awarded towards outreach and marketing would not be changed as the reduction in service hours does not impact the outreach to be performed.

<u>Recommendations</u>: The MSRC-TAC Scope Changes Subcommittee will review the request and their recommendations will be brought forward at the MSRC-TAC meeting. The MSRC Contracts Administrator recommends approval.

RE: Modification to Funding Award for Microtransit Service

#### Dear Ms. Ravenstein,

We appreciate the Committee's award of funds to our Microtransit project. We are excited to launch the service and want to ensure we have the most accurate information for the contract with MSRC so that we can obtain our City Council approval at our earliest opportunity. To further that effort, we wanted to provide an update as to two items that have been modified from the original application. There are two modifications, one of which may require a reduction in the total project cost, and thus our requested grant amount.

When we submitted the initial proposal in March 2023, we were in the beginning stages of development for our Microtransit program. At that time, we provided our initial design of the service based on the information we had at the time. As we are nearing the launch of the service, we have had to make some adjustments to our original plan and thus presented these to our Council for approval in December 2023. The adjustments were made based on GTrans' difficulty hiring drivers for the program, and feedback from customers on the proposed fares.

#### Fares

We initially proposed in the grant application that our fares for the paratransit portion of our customers would be \$1.50, which is higher than the current fare of \$0.75. The feedback from our customers was that the cost increase was too great. As a result, we opted to keep the fare at \$0.75. Fare revenue was used in the application as part of GTrans' local match to the overall project. The impact is calculated at a loss of \$5,250 in projected fare revenue. GTrans commits to providing the same level of match funding as proposed in the original grant application, despite the lower paratransit fare we will recoup.

#### Service Hours

As we have been working to hire drivers for this service, we have not had the turnout and followthrough we anticipated. Because of that, we do not have enough drivers to operate the service as originally planned and noted in the grant application.

Also, we will reduce the hours of operation by one hour during the week, also based on manpower. The changes are noted below.

As a result of these changes and based on our recalculation of the new weekly service days and hours, we believe there should be a reduction of 11 hours per week or 12.5 percent, in Task III Operate Service line item. The 12.5 percent amounts to an overall reduction of \$154,847 in the total Task III cost, with a corresponding reduction in the grant funding (\$51,178) and GTrans co-funding (\$103,669). Please see the table below:

SUBJECT:	Consider Proposed Modifications to MSRC "Operational Policies and Procedures"
SYNOPSIS:	The MSRC's "Operational Policies and Procedures" were originally adopted in 1993 and amended with respect to the Regional Rideshare Agency in 2020. This item provides a more comprehensive set of recommended updates for consideration.
FINANCIAL IMPACT:	None
<b>RECOMMENDATIONS:</b>	The MSRC Contracts Administrator recommends approval
ATTACHMENTS:	MSRC "Operational Policies and Procedures" with recommended changes noted

The MSRC's "Operational Policies and Procedures" were originally adopted in 1993. In 2020, the MSRC adopted amendments focused on the Regional Rideshare Agency elements of the document. Given that some provisions are no longer completely up to date, the MSRC provided direction for staff to bring back suggested modifications.

#### Key Recommended Language Changes:

- The proposed revisions make apparent that the MSRC-TAC, in addition to the MSRC, is subject to the Conflict of Interest Code.
- In the early 2010s, direction was provided to MSRC staff to reduce the amount withheld pending MSRC review for *public agency* final reports to 5%, rather than 10%. The reduction likely stemmed from a provision in California Public Contracts Code regarding retention of proceeds from contractors by public entities. A decade's application of a 5% withhold for these contractors/award recipients has demonstrated that whether the withhold is 5% or 10%, it is still sufficient to motivate the final report's submission. Therefore, for simplicity and consistency, a standard withhold of 5% is recommended for any funding recipient (public or private).

The other changes would revise the policy language to be consistent with current practices, including but not limited to:

- Administrative costs which fall within the approved administrative budget are approved by South Coast AQMD Executive Officer or designee;
- Inquiries which require interpretation or which raise issues likely to be subject to significant public scrutiny are to be brought before the MSRC Chairperson. This allows District staff to respond to inquiries which simply require conveying factual information.

Please note that the 1991 & 1992 "Enacted Policy Decisions of the MSRC", which were included on the final page of the document, are proposed to be stricken as they have been incorporated or superseded in other proposed or current policies.

# OPERATIONAL POLICIES and PROCEDURES

### Mobile Source Air Pollution Reduction Review Committee Membership

The Mobile Source Air Pollution Reduction Review Committee (MSRC) shall be comprised of one representative from each of the following agencies:

- (1) South Coast District (South Coast Air Quality Management District (SCAQMD);
- (2) Southern California Association of Governments (SCAG);
- (3) San Bernardino County Transportation Authority (SBCTA);
- (4) Los Angeles County Metropolitan Transportation Authority (MetroLACMTA);
- (5) Orange County Transportation Authority (OCTA);
- (6) Riverside County Transportation Commission (RCTC);
- (7) State Board (California Air Resources Board CARB);
- (8) A regional rideshare agency selected by the other members of the MSRC committee.

## [See Health & Safety Code § 44244(a).]

The MSRC elects to rotate the regional rideshare agency position between SBCTA, OCTA, RCTC and LACMTAMetro. Effective April 16, 2020, SBCTA shall be designated as the regional rideshare agency and this designation shall continue for two years. OCTA shall succeed SBCTA as regional rideshare agency, followed by RCTC and then LACMTA, each for a period of two years. This rotation shall continue in subsequent years.

All appointments for members and alternates shall be made by the respective appointing authority. Notice in writing shall be submitted to the Chairperson of the MSRC. The authorized appointing authority may reappoint or fill a vacancy by giving notice in writing to the MSRC Chairperson.

## **Technical Advisory Committee Membership**

The Technical Advisory Committee (**MSRC**-TAC) shall be comprised of membership as approved by the MSRC with one representative appointed by each of the following agencies:

- (1) MSRC representative from the South Coast District (South Coast Air Quality Management District (SCAQMD);
- (2) MSRC representative from the Southern California Association of Governments (SCAG);
- (3) MSRC representative from the San Bernardino County Transportation Authority (SBCTA);
- (4) MSRC representative from the Los Angeles County Metropolitan Transportation Authority (LACMTAMetro);
- (5) MSRC representative from the Orange County Transportation Authority (OCTA);
- (6) MSRC representative from the Riverside County Transportation Commission (RCTC);
- MSRC representative from the State Board (California Air Resources Board CARB);
- (8) MSRC representative from the regional rideshare agency selected by the other members of the MSRC;
- (9) Cities of San Bernardino County;
- (10) Cities of Riverside County;
- (11) Cities of Orange County;
- (12) Cities of Los Angeles County;
- (13) Board of Supervisors of San Bernardino County;
- (14) Board of Supervisors of Riverside County;
- (15) Board of Supervisors of Orange County;
- (16) Board of Supervisors of Los Angeles County;
- (17) And members selected by the MSRC as it deems appropriate.

# [See Health & Safety Code § 44244(c).]

## **Duties of the MSRC:**

The duties of the MSRC are to develop, adopt and implement a work program pursuant to section 44244(b) of the California Health and Safety Code, and to present such work program(s) for approval to the south coast district board. The MSRC may, from time to time, amend, readopt, and resubmit the work program to the district board for approval.

## **Duties of the MSRC-TAC:**

The duties of the Tac MSRC-TAC are to assist the MSRC in the development of the work program, pursuant to section 44244(b) of the California Health and Safety Code, and to

present recommendations for approval to the MSRC, and to perform those additional duties as may be required by the MSRC.

# Policies Adopted by the MSRC

### **Policy #1.** Membership of the MSRC shall be as follows:

- 1. There shall-may be designated alternate representatives for the MSRC. The appointing authority shall submit the name of the alternate in writing to the MSRC eChairperson. The appointing authority can change their designated representative(s) at any time by giving notice in writing;
- 2. With the exception of the CARB representative, no representative shall serve on both committees the MSRC and MSRC-TAC.
- Policy #2. Annually, during the month of May, or at the next meeting if the MSRC does not meet in May, the MSRC shall elect a Chairperson and Vice Chairperson by majority vote of MSRC members present. The MSRC Chairperson and Vice Chairperson must-be an elected official or voting board member of the voting agency or authority the individual is representing and cannot be the SCAQMD or the CARB representative on the MSRC. The Chairperson and Vice Chairperson can serve for as many terms as election results allow.
- Policy #3. The Chairperson and Vice Chairperson of the MSRC-TAC shall be elected annually in the month of May, or at the next meeting if the MSRC-TAC does not meet in May, by majority vote of the MSRC-TAC members present. The MSRC-TAC Chairperson and Vice Chairperson can serve for as many terms as election results allow.
- Policy #4. MSRC and MSRC-TAC members shall comply with the SCAQMD's *Conflict of Interest Code.* [See SCAQMD Admin. Code § 42; Gov't Code §§ 1090, 81000 et seq., 84308.]
- **Policy #5.** Procedure for MSRC meetings shall be as follows.
  - 1. Regular Meetings shall be held at least bi-monthlyevery two months.
  - A majority of the voting members of the MSRC shall constitute a quorum, and all action at a meeting shall require the affirmative vote of a majority of the voting members, that is, at least a quorum. [See Health & Safety Code § 44244(b)(1)]. At least a quorum of the members shall participate from locations within MSRC jurisdiction. [See Gov't Code § 54953(b)(3).]

- 3. At any regular meeting not held for lack of a quorum, the members present, if less than a quorum, may constitute themselves a "Committee of the Whole", for purposes of discussing agenda matters or any other matter of interest to the members present. The committee shall automatically cease if a quorum is reached.
- 4. The Chairperson may designate standing and ad hoc committees subject to the concurrence of the MSRC members and shall make appointment to all committees.
- 5. All agenda items shall be submitted by MSRC members in writing to the committee secretary 15 days prior to the next scheduled meeting with a written copy to the Chairperson.
- 6. The MSRC meetings shall be conducted, and public comments allowed, in accordance with the Ralph M. Brown Act. Public comments shall be limited by the discretion of the Chairperson.
- 7. Rules and procedures shall be at the discretion of the Chairperson and consistent with both state and federal laws.
- **Policy #6.** The procedure for developing the work program shall be as follows.
  - For each work program, Fthe MSRC, with the assistance of the Technical Advisory Committee (MSRC-TAC), shall develop a list of priority areas for the reduction of mobile source emissions for funding. The default frequency for work program development is yearly, but the MSRC can consider adoption of a multi-year work program. The list will be organized by category and target funding level. In addition, the MSRC, with the assistance of the MSRC-TAC, shall develop a-Requests for Proposals (RFPs) or other solicitations RFPs-reflecting these priorities and submit it-them to the SCAQMD Governing Board for approval.
  - The MSRC shall -develop a description of the selection process and criteria to be used in evaluating proposals. This information shall be included with the RFPs and also be available for public inspection at the District headquarters.
  - A bidder's conference shall-may be conducted subsequent to the mailing release of the RFP, to specify RFP requirements, evaluation criteria and process, and answer questions the prospective applicants may have.
  - 4. The MSRC/**MSRC**-TAC/<del>Consultant Advisor</del>**District staff** shall adhere to District and MSRC Policy in the issuance of RFPs and receipt of proposals.
  - 5. Upon receipt of proposals in response-to-the RFP, the MSRC-TAC, with the assistance of the MSRC's **t**Technical Consultant-Advisor, shall evaluate the proposals for funding and provide initial funding recommendations to the MSRC. District's technical staff may participate in the evaluation process as mutually agreed upon by the MSRC and the District.

- 5. During proposal review, the MSRC Contracts Administrator in consultation with the Technical Advisor shall perform a due diligence review and recommend to the MSRC to eliminate any costs or work tasks found to be unjustifiable or unwarranted.
- 6. The **MSRC**-TAC will forward this-its initial evaluation to the MSRC for its consideration. No ex parte communications will occur between any proposer and the **MSRC or MSRC**-TAC members beginning with the closing-release date of the RFP through the date of submittal of the recommended projects to the MSRC unless the MSRC directs oral reviews as part of the evaluation process. In transmitting the work program to the MSRC, the **MSRC**-TAC recommendations shall include:
  - a) A rank order listing of all projects by category with a demarcation of the targeted funding level;
  - b) A description of each project including estimated emissions reductions as appropriate and a statement demonstrating the extent of compliance with the Clean Air Act, or the 1991 AQMP, or its successor plans [See Health & Safety Code § 44244(d)];
  - c) The amount of funding and co-funding, if appropriate, recommended and any conditions **such as co-funding requirements** associated with the recommendation.
- 7. The Consultant Advisor District staff shall notify all applicants of the MSRC-TAC work program recommendation to MSRC and of the time, date and place at which the MSRC will consider it.
- 8. The MSRC will review the MSRC-TAC recommendations. and adjust, change or reevaluate any or all proposals as the lf the MSRC deems appropriate, the MSRC can direct the MSRC-TAC to reevaluate any or all proposals and bring back potentially revised recommendations or re-evaluate all proposals itself. Upon final selection of the successful applicants and adoption of the listing by the MSRC, a work program will be submitted to the SCAQMD Governing Board for approval. Upon approval by the SCAQMD, or as deemed approved by law, and not before, the successful applicants will be formally notified of their selection. [See Health & Safety Code § 44244(b)(2).]
- 9. In transmitting the work program to the **SC**AQMD Governing Board, the MSRC shall provide:
  - a) A cover letter requesting funding approval for the successful applicants;
  - b) A listing of proposals recommended for funding;
  - c) A description of each project including resulting estimated reductions in mobile emissions, if appropriate or the manner of compliance with the California Clean Air Act of 1991, as amended, or the District"'s Air Quality Management Plan, as amended;

- d) The amount of funding recommended and any conditions associated with the recommendation.
- 10. MSRC staff will prepare a letter with the adopted work program for District Governing Board consideration. Items will only be placed on the work program letter for consideration only if requested materials from the project proponent are timely received, e.g., campaign contribution disclosures. The Chairperson of the MSRC shall be responsible for communicating the MSRC-"s adopted work program to the District-"s Governing Board for approval.
- 11. All unsuccessful applicants will be notified after the work program is approved.
- 12. With each successful applicant, District staff and the Consultant Advisor shall negotiate a statement of work and a contract. Prior to execution of the contracts between the successful applicants and the District, the MSRC shall review the standard contract language.
- 13. During contract negotiation, the Consultant Advisor shall perform a due diligence review of successful applicants and recommend to the MSRC to eliminate any costs or work tasks found to be unjustifiable or unwarranted.
- **14.13.** The District staff and the Consultant Advisor are authorized to enter into contract negotiations with the successful applicants. Negotiations are to be within the approved funding limit. The 5% variance margin can be approved by a MSRC subcommittee appointed for that specific purpose. Negotiations outside this range are to be referred back to the MSRC for committee action and District Governing Board approval prior to contract signing.
- **15.14.** An amount of **105**% of each recipient<sup>2</sup>'s funding will be withheld pending review of the final report for compliance by the MSRC. **The MSRC may choose to waive this requirement for specific programs.**
- **16.15.** All contracts resulting from implementation of the MSRC work program shall be processed on a first in, first out basis, respecting account schedules and draw down issues.
- 17.16. Costs associated ÷with the administration of the work program are to be charged to the AB 2766 Discretionary Fund. The Chairperson of the MSRC and the SCAQMD Executive Officer or designee shall approve all administrative invoiced costs prior to payment. -
- Policy #7. The MSRC--TAC Chairperson shall appoint a subcommittee to facilitate contracts. The Subcommittee will work with the MSRC's Consultant AdvisorDistrict staff and make decisions-recommendations regarding specifying therequested changes to contracts scope of work to be contained in the contract to reflect the intent of the MSRC in adopting the work program. Any significant issue or change in scope, as determined by the MSRC Chairperson, shall be forwarded to the MSRC for a full committee policy decision.

- **Policy #8.** The District and the MSRC's Consultant Advisor shall track the -expenditures of the AB 2766 Discretionary Fund account and report monthly to the MSRC. This will insure sufficient funds being available at the beginning of January of each accounting year to fund the next year's successful applicants for their one year time period of performance.
- Policy #9. The funding cycle for the AB 2766 Discretionary Fund Program shall be from July 1 to June 30 of the following year. -The MSRC, working with the District staff, shall establish a contracting and disbursement schedule to maximize the utilization of funds while maintaining a prudent balance to meet all required contractually obligated funding. The MSRC shall annually adopt adeadlines schedule for the submission , evaluation, and approval of work program projects. As noted in Policy #6 above, the MSRC may consider a multi-year work program.
- **Policy #10.** The MSRC shall require, as a contract condition, that each funding recipient prepare a final report upon the conclusion of the project and submit the report to the MSRC for approval. The contents of the final report shall be determined by the TAC, with the assistance of the Consultant Advisor. Using the information from the final report<del>s</del>, and other such information and analysis as may be appropriate, the MSRC shall authorize the final <del>105</del>% payment to the recipient. Annually, the MSRC, as appropriate shall submit to the District Board a report on all projects completed during the preceding year.
- Policy #11. To protect the interest of the MSRC and the District in the event an AB 2766 Discretionary Fund applicant becomes insolvent or files for bankruptcy during the term of the contract or does not complete the intent of the project, where **appropriate**, contract terms and conditions shall include language directing that title to equipment purchased for the performance of this contract with AB 2766 Discretionary Funds shall revert to the District for disposition to the AB 2766 Discretionary Fund account the funding recipient grants SCAQMD a security interest in any and all equipment purchased. Contract terms and conditions shall also include provisions for repayment of monies to the AB 2766 Discretionary Fund account in the event that activities funded result in an item or concept being patented and made commercially available. The limit of repayment will be to the level of the original applicant funding amount. Products resulting from non-profit or government agency expenditure of AB 2766 Discretionary Funds will be in the public domain and made available at cost.

- Policy #12. The Consultant Advisor District staff shall maintain a database of all work program projects. All funded projects must submit a final report containing the project's achievements and the project's mobile source emission reduction findings that shall be maintained in the database. The database and final report information will be made available, in accordance with the contract terms for each funded project, the District's Records Retention Policy, the District's Guidelines for Implementing the California Public Records Act, and the Public Records Act, to the public by requests made through the Public Records Unit of the District.
- Policy #13. All inquiries Any inquiries where there may need to be interpretation regarding actions taken by or policies of the MSRC, MSRC/-TAC, or MSRC/ ConsultantTechnical Advisor or where the issues raised are likely the subject of significant public scrutiny are to be brought before the MSRC Chairperson.MSRC for response and disposition ... The MSRC Chairperson is the designated spokesperson and may choose to involve the MSRC prior to response or disposition.
- Policy #14. The MSRC shall treat all successful applicant proposals as fixed price contracts for a negotiated statement of work. For payment purposes, the contractor shall submit an itemized invoice to the Consultant AdvisorDistrict staff referencing a milestone (task) completed or a percentage of work accomplished (monthly progress payment) and detailing line item expenditures against the Cost Schedule of the contract. On a case-by-case basis, Tthe Consultant Advisorfunding recipient may request MSRC approval for an alternative payment method, such as advance payment. The Consultant AdvisorDistrict staff shall verify the accuracy of the invoice and the accomplishment of the technical milestones/progress claimed.
- Policy #15. The existing policy of the MSRC is to develop a work program based on anticipated revenues for a funding cycle beginning July 1 and ending June 30 of the following year. As noted in Policy #6 above, the MSRC may consider a multi-year work program.

#### Enacted Policy Decisions of the MSRC

The representative of each of the agencies comprising the MSRC, as specified in the California Health & Safety Code, must be designated in writing by their agency and must be an elected official. The agencies can change their designated representative at any given time by giving notice in writing. - January 17, 1991.

A representative and an alternate to the MSRC must be designated in writing by each agency specified in the Health & Safety Code and each must meet the same criteria. The alternate must be designated to vote, when acting in the absence of the representative, for the agency they represent. - January 17, 1991.

The chair of the MSRC must be an elected official and neither the SCAQMD representative or the CARB representative can chair the Committee. - January 17, 1991.

The initial designated rideshare agency will be Commuter Transportation Services. - January 17; 1991.

Members of the TAC shall not include any person serving as a member of the MSRC nor as an alternate to the MSRC. - January 17, 1991.

All contracts resulting from implementation of the MSRC work program shall be processed on a first in, first out basis, respecting account schedules and draw down issues. – January 27, 1992.

The MSRC Chair, or the Chair's designee shall be granted the authority to work with the •MSRC's Consultant Advisor to make decisions on revising contract language and to decide whether or not an issue must be forwarded to the MSRC for a full committee policy decision.-- March 23, 1992.

The administrative contract management for the MSRC shall be authorized to have discretion of a 5% funding flexibility. - March 23, 1992.

The MSRC members shall adopt and comply with the SCAQMD's Conflict of Interest Code. -May 14, 1992.

The MSRC shall allow public comments to be heard, comments shall be limited to two minutes per speaker. - October 26, 1992.
