	This agreement was previously extended by 24 months. The County of Los Angeles requests an eight-month term extension due to delays resulting from their existing contractor filing for bankruptcy, and supply chain challenges which are delaying delivery of the switch gears that have been ordered. The MSRC Contracts Administrator recommends approval.	

#### FY 2021-24 WORK PROGRAM

6. Consider Approval of FM Harbor LLC as a Party to Agreement with Forum Mobility Inc., Agreement #MS24998 (proposed) (\$6,000,000 -Install Electric Vehicle Service Equipment (EVSE) at the Port of Long Beach)

In January 2025, the MSRC approved a \$6,000,000 contract award to Forum Mobility Inc. as part of their partnership with the Ports of Long Beach and Los Angeles (POLB and POLA). This award uses funds exclusively from the POLB and POLA EVSE Infrastructure Projects Special Revenue Fund (92) with MSRC acting to administer the project. After the award, MSRC staff were notified that another entity, FM Harbor LLC, now holds title to the charging infrastructure. It is recommended that the MSRC approve the addition of FM Harbor LLC as a party to the agreement.

#### FY 2024-27 WORK PROGRAM

- 7. Nikravan Consider Contract Value Increase by Geographics, Contract #MS21006 (\$21,421 – Host & Maintain MSRC Website) In April 2021, a contract was executed with Geographics for supporting the MSRC website. The tasks under this contract included hosting the MSRC website, conducting routine maintenance, and making website revisions to integrate new features as needed. Previous modifications have added funds and extended the term of this contract, with a current term ending September 20, 2025. Hosting of the website will be transitioning to a hew host within the next two to three months. Based on the amount of time remaining under this contract and the remaining balance, it is the MSRC Contracts Administrator's recommendation to increase the contract value by \$1,000 to cover any unanticipated maintenance needs. Any funds not used at contract termination will revert back to the AB2766 Discretionary Fund. 8. Consider Potential Next Steps for MSRC Technical Advisor Services
- The MSRC retains an independent contractor to provide technical assistance in support of the AB 2766 Discretionary Fund Program. The contract with the current Technical Advisor expires on December 31, 2025. The purpose of this item is to consider potential next steps. No written material. The MSRC-TAC Administrative Subcommittee was convened to consider the item; a quorum was not present. Subcommittee members present recommended approval.

- BNSF Railway BNSF San Bernardino Electric Yard Tractor Charging Infrastructure, Contract #MS21023

A summary of each Final Report is attached. MSRC staff has reviewed the Final Reports and recommends approval.

# ConGlobal – Zero-Emission Cargo Handling Equipment & Infrastructure at Warehouse, Distribution, & Intermodal Facilities

Project Description & Work Performed: The project under Agreement No. MS21009 involved the replacement of 12 diesel yard tractors with 12 zero-emission electric yard tractors at the San Bernardino facility. Funding from the Mobile Source Air Pollution Reduction Committee (MSRC) was crucial for project viability.

The project commenced in 2023, and was completed on December 29, 2024. The project encountered delays due to infrastructure issues with Southern California Edison (SCE). An easement exists between the property where the chargers were to be installed and another area where SCE has power, and the process to allow SCE to cross the easement proved lengthy.

A second issue involved multiple maintenance and operational issues with the BYD electric yard tractors. The downtime experienced increased operations costs and resulted in scaling back the purchase number from 50 to 12 electric yard tractors.



Emission Reductions: The ConGlobal zero-emission yard tractor project is expected to result in the following total emission reductions over a five-year equipment life:

Emission Reductions (Tons) Over Five Year Life

Oxides of Nitrogen (NO <sub>x)</sub>	1.0771
Reactive Organic Gases (ROG)	0.5745
Diesel Particulate Matter (DPM)	0.0467

In addition, the project will reduce greenhouse gases in an amount estimated at 1,716,900 kg annually.

### BNSF Railway – BNSF San Bernardino Electric Yard Tractor Charging Infrastructure

Project Description & Work Performed: The project involved installation of charging infrastructure to support the operation of 12 electric yard tractors at BNSF's San Bernardino Intermodal Facility. The electric yard tractors are owned and operated by ConGlobal (*See summary of project #MS21009, above*).

During the first quarter of 2023, BNSF purchased six (6) Heliox 180 charging cabinets, each with three dispensers. BNSF also purchased a Siemens 2500-amp switchgear during this same timeframe. BNSF finalized the electric charging infrastructure design, and selected Aldridge Electric as the General Contractor. In December 2023, construction of the charging infrastructure area broke ground. The Heliox charging cabinets and dispensers were put into place in April 2024 and enabled for charging activity pending site electrification by Southern California Edison (SCE).


To energize the charging infrastructure, SCE was required to connect the switchgear to the powerline located along a nearby road. However, SCE notified BNSF that there was an easement issue due to a small parcel of land that is owned by the City of San Bernardino on which the powerline is located.

SCE was ultimately able to resolve the easement issue with the City, but this delayed the electrification of the site by approximately one year. Additionally, SCE was further delayed by approximately one month due to the wildfires that impacted Southern California in January 2025.

Once the easement was established, SCE was able to complete the necessary work to connect the switchgear to the powerline and get the site electrified. This work was completed in February 2025.

The final step involved commissioning each individual charger. A Heliox technician visited the site over a two-week period to commission each charger unit. This involved connecting each charger to a laptop computer, performing the necessary updates, installing required patches, and testing the functionality of each charger. This was completed on February 24, 2025, and the Heliox chargers were considered fully operational at this time.

On April 22, 2024, BNSF and ITSC conducted a public outreach event on ITSC's Future-Focused Terminal Podcast for their Earth Day episode entitled, "Moving the Needle: ESG and Decarbonizing Freight." This represents the project's biggest public-facing information outreach event. The podcast event featured discussion of freight terminal electrification with a look at the Barstow Intermodal Facility electric yard tractor project, decarbonization goals, and partnership with MSRC. #### **Contract Execution Status**

#### 2021-24 Work Program

On September 2, 2022, the SCAQMD Governing Board approved an award under the Major Event Center Transportation Program. This contract is executed.

On February 3, 2023, the SCAQMD Governing Board approved an award under the Transformative Transportation Strategies & Mobility Solutions Program. This contract is executed.

On June 2, 2023, the SCAQMD Governing Board approved six awards under the Microtransit Service RFP, for zero-emission shared mobility service. These contracts are executed.

On September 1, 2023, the SCAQMD Governing Board approved two awards under the Publicly Accessible Goods Movement Zero Emission Infrastructure Request for Information. One of these contracts will be administered by SCAQMD on behalf of the MSRC, and the other award is conditional upon successful selection of a site developer and operator and securing co-funding commitments. These contracts are under development.

On February 2, 2024, the SCAQMD Governing Board approved allocations for partnership in applications seeking funding under the Carl Moyer Program solicitation. Some of the applications were subsequently awarded funding Carl Moyer funding. To the extent feasible these contracts will be administered by SCAQMD on behalf of the MSRC; these contracts are under development.

#### 2024-27 Work Program

On October 4, 2024, the SCAQMD Governing Board approved an award for programmatic outreach services for the MSRC. This contract is executed.

On December 6, 2024, the SCAQMD Governing Board approved an award for partnership on the West Coast Truck Charging and Fueling Corridor Project. This contract is under development. The SCAQMD Governing Board also approved three allocations for partnership with SCAQMD on technology advancement projects. To the extent feasible these contracts will be administered by SCAQMD on behalf of MSRC; these contracts are under development.

On April 4, 2025, the SCAQMD Governing Board approved an award for hosting and maintenance of the MSRC website. This contract is under development.

SUBJECT: FY 2025-26 Administrative Budget

SYNOPSIS: As part of the annual MSRC budget, administrative costs are limited to not more than 6.25 percent of the annual MSRC portion of the AB 2766 revenues. Each year, an administrative budget is prepared. For FY 2025-26, the projected administrative costs are \$1,011,185 against a cap of \$1,041,473.

RECOMMENDATION(S): Review and approve the attached FY 2025-26 Administrative Budget, and forward it to the MSRC for review and approval.

## BACKGROUND:

California Health & Safety Code, Section 44233, limits the administrative expenses for the MSRC to not more than 6.25 percent of its annual AB 2766 revenues. Each year, an administrative budget is prepared for review and approval by the MSRC.

## DISCUSSION:

The proposed FY 2025-26 Administrative Budget is \$1,011,185 as shown in the attachment. The projected 6.25 percent administrative cap is \$1,041,473, leaving a margin of \$30,288. The following elements apply to these projections:

## (1) Staff Salaries:

Costs are projected for three full-time staff positions (one Program Supervisor and two Contracts Assistants), and two part-time positions (one Planning & Rules Manager and one Senior Administrative Assistant).

## (2) <u>Staff Administrative Support</u>

South Coast AQMD charges MSRC for certain support functions provided to the MSRC. This includes legal, financial, and contractual support. The estimated hours reflect resources spent by the support functions.

## (3) Burdened Rates:

South Coast AQMD charges MSRC burdened rates for its staff positions and other administrative support personnel. The fully burdened hourly rate reflects the FY 2025-26

proposed overhead rates and the existing South Coast AQMD labor agreement resulting in an increase of \$45,625 in staffing costs.

## (4) Miscellaneous Direct Costs:

These costs include: (1) annual travel costs of \$2,500; (2) \$5,000 for conference-related expenses and (3) miscellaneous expenses, such as printing, mailing, refreshments, etc., in the amount of \$48,500.

## (5) <u>Revenues:</u>

Based on receipts for the AB 2766 program, the revenue projection has been revised to reflect the current trend in revenue collections.

In summary, the projected FY 2025-26 Administrative Budget reflects the best and most reasonable cost estimates that are currently available.

SYNOPSIS:	This agreement was previously extended by 24 months. The County of Los Angeles requests an eight-month term extension due to delays resulting from their existing contractor filing for bankruptcy, and supply chain challenges which are delaying delivery of the switch gears that have been ordered, as part of the FYs 2016-18 Local Government Partnership Program.

## **DISCUSSION:**

Funding Recipient:	County of Los Angeles
Project Title:	Purchase 29 Light-Duty Zero Emission Vehicles (ZEVs), 6 Heavy-Duty Near-Zero Emission Vehicles, and Install EV Charging Stations
MSRC Funding:	\$1,273,938
Project Term:	October 5, 2018 to August 4, 2028
Current Request:	8-month term extension
Previous Requests:	24-month term extension

<u>Project Description:</u> The MSRC awarded the County \$1,367,610 to purchase 29 light-duty ZEVs, 1 heavy-duty ZEV, and 6 heavy-duty near-zero emission vehicles, and install 185 Level II EV charging stations. Contract #ML18060 was executed to effectuate the award. Last year, the County requested a change in scope by eliminating the heavy-duty ZEV which reduced the contract value to \$1,273,938. All the light-duty ZEVs and near-zero emission vehicles have been placed into service, 114 stations have been installed, and \$724,868.96 has been paid to date.

<u>Previous Request:</u> In 2022, the County requested a 24-term extension from August 2026 to August 2028. Then in 2024, the County requested to reduce the project's scope by eliminating the zero-emission heavy-duty vehicle, with a corresponding value reduction from \$1,367,610 to \$1,273,938. They also requested a change in the deliverable date for the EV charging stations, however, this did not result in any change to the contract term.

<u>Contract Request:</u> The County is requesting an eight-month term extension due to delays resulting from their existing contractor filing for bankruptcy, and supply chain challenges which are further delaying delivery of the switch gears that have been ordered. As a result of the County's existing contractor filing bankruptcy, they were unable to cancel their contract or rebid the work until all contractual processes were completed. They now have a new vendor who is under contract and will complete the remainder of the project. Furthermore, the average wait time for these switch gears is taking upwards of 25 to 30 weeks from the time the order is placed. The County is confident that this term extension will afford them the added time needed to complete the remaining elements under this contract.

MSRC staff has reached out to the County to inquire about whether an evaluation has been conducted to assess the potential need for additional switch gears, and if a need was identified, whether an order has been placed with an anticipated delivery date. In addition, an inquiry was made about the current rebid status for their last two project sites that are expecting completion by March 2026.

<u>Recommendations</u>: The MSRC Contracts Administrator recommends approval. The extension is recommended because the County has experienced unanticipated delays which are outside of their control.

## **Request to Modify Contract**

The County of Los Angeles Internal Services Department (ISD) is submitting a request to modify Contract No. ML 18060B which terminates on August 4, 2028. Specifically, the County requests the following modifications:

- 1. Modify the completion month that electric vehicle charging stations are put into service from month 78 to month 89 through March 30, 2026, and
- 2. Modify the contract term to extend it to April 5, 2029

## Four factors are impacting the timing to complete projects.

First, as was stated in our request for amendment 18060b last year, many of the County's projects have been replacement projects, which are not eligible for MSRC 18060 grant funds. Specifically, in 2019 the County switched to an EV charging station network provider with advanced technology that could respond to demand response events consistent with Southern California Edison rules. As a result, the County focused on removing and replacing non-compliant charging stations as its priority. The County completed those replacements in 2024, and was then able to identify new projects to utilize MSRC funds for projects it would not otherwise be able to complete.

Second, several projects in the last two years have been eligible for SCE Charge Ready rebates, so the County has not requested to use MSRC funds for them.

Third, ISD's contractor on several of its project PLEMCo- Pacific Lighting Manufacturer Company filed for bankruptcy on April 17, 2025. PLEMCo began to struggle meeting project deadlines in August, 2025. ISD could not cancel its contract with PLEMCo or rebid the work, until all contractual processes with PLEMCo were completed. As a result, several projects that were partially started, then halted, are now being managed by new contractors. For example, one of the projects that was being installed by PLEMCo was the 33 charging stations at the Olive View Medical Center in Sylmar, CA. The project was originally supposed to be completed in August of 2024.

MICHAEL OWH Director Several stages of the project were completed by PLEMCo, including having stamped drawings and moving transformers into place. The project will be completed by a new vendor, Vector Energy, which is now under contract.

Fourth, even with new contractors in place to resume work on the projects, ISD has also faced delays in the timing for switch gear to be delivered. For example, once a contractor identifies that switch gear is needed, it takes between 25 and 30 weeks to receive it.

# ISD is committed to completing the work and has demonstrated its ability to maintain charging stations long term.

ISD has identified the following project sites for MSRC funds. All of the projects except the last two are in progress.

Since MSRC 18060 was first funded, ISD's has created the Clean Transportation and Energy Program, which has a team dedicated to maintaining charging stations. CTEP's uptime regularly exceeds the state requirements with a consistent average of 98.8% of charging stations up and running at all times. The table below shows that all of the charging station projects installed in the last five years through MSRC funds are continuing to generate benefits for SCAQMD. The table also shows the cumulative kWh usage, GHG savings, and total miles driven as a result of the charging stations that have been installed through MSRC 18060 funds. These projects have resulted in a reduction of 289 metric tons of GHG emissions.

## ISD will not be able to complete these projects without MSRC funds.

ISD has been fiscally responsible, only using MSRC 18060 grant funds when it did not have other funding sources such as SCE Charge Ready funding or funding from another grant. However, the County is expecting unprecedented financial challenges in the coming fiscal year, due to recovery from the wildfires, a lawsuit, and shifts in support from the federal government. Every division in ISD is preparing a report to demonstrate how it will be cutting costs in the next fiscal year. ISD is leveraging our grant match commitments to justify needing County funding. As a result, we are committed to continuing to provide the match contribution. Unfortunately, without MSRC 18060 funds, the County will not cover the costs for the balance of each project. As a result, we may end up with drawings for some projects, but we will not be able to install 71 charging stations. As a best case scenario, we may be able to cover the cost of completing one project that is furthest along.

When ISD installs charging stations, we see a rapid increase in station use. Our data consistently demonstrates that the demand exists for charging stations and it is continuing to grow. However, we surveyed nearly 800 county residents and of the residents that already have an electric vehicle, 25% indicated they were considering switching back. The concern that most

EV drivers raised was lack of charging stations. Cancelling these projects will have direct impacts on communities in the South Coast Air Quality Management District. Communities that don't receive charging stations may have lower rates of EV adoption. The result could be fewer opportunities to reduce our greenhouse gas emissions and the pollution burdens our communities face.

In contrast, with this amendment to the agreement, the County looks forward to being able to complete the remaining requirement to install 185 EV charging stations as part of ML 18060 and contribute more benefits to improving air quality in the South Coast Air Quality Management District.

In closing, the County welcomes any questions from MSRC and looks forward to a response.

SYNOPSIS:	In January 2025, the MSRC approved a \$6,000,000 contract award to Forum Mobility Inc. to install electric vehicle service equipment (EVSE) at the Port of Long Beach as part of the MSRC's partnership with the Ports of Long Beach and Los Angeles (POLB and POLA). This award uses funds exclusively from the POLB and POLA EVSE Infrastructure Projects Special Revenue Fund (92) with MSRC acting to administer the project. After the award, MSRC staff were notified that another entity, FM Harbor LLC, now holds title to the charging infrastructure.
FINANCIAL IMPACT:	None
RECOMMENDATIONS:	In order to enhance accountability and enforceability in administration of the project, it is recommended that the MSRC approve the addition of FM Harbor LLC as a party to the agreement.

SUBJECT:	Consider Contract Value Increase by Geographics, Contract #MS21006
SYNOPSIS:	In April 2021, a contract was executed with Geographics for supporting the MSRC website. The tasks under this contract included hosting the MSRC website, conducting routine maintenance, and making website revisions to integrate new features as needed. Previous modifications have added funds and extended the term of this contract, with a current term ending September 20, 2025. Hosting of the website will be transitioning to a hew host within the next two to three months.
RECOMMENDATION:	Based on the amount of time remaining under this contract and the remaining balance, it is the MSRC Contracts Administrator's recommendation to increase the contract value by \$1,000 to cover any unanticipated maintenance needs and ensure that the website remains operational with uninterrupted service and functionality. Any funds not used at contract termination will revert back to the AB2766 Discretionary Fund.
WORK PROGRAM IMPACT:	Sufficient funding for this contract value increase is available in the AB 2766 Discretionary Fund and will be included in the FYs 2024-27 Work Program.
